# SPECTRAL ENERGY OF DIRAC OPERATORS FOR FERMION SCATTERING ON TOPOLOGICAL SOLITONS IN THE NONLINEAR $O$ (3) $\sigma$-MODEL

#### Abstract

We present a criteria affirming the existence of discrete ground states of the Dirac operators which describe the fermion scattering on topological solitons in the nonlinear $O(3) \sigma$-model. Additionally, we investigate a sufficient condition that elucidates the phenomenon of supersymmetry breaking within the supersymmetric quantum mechanics associated with this Dirac operator.


## 1. Introduction

Topological solitons of nonlinear field models play an important role in field theory, condensed matter physics and hydrodynamics etc (see e.g. [7, 8]). In this paper, we study the Dirac operators which describe fermion scattering on topological solitons in the nonlinear $O(3) \sigma$-model (see [6] for details). Moreover, we investigate whether the supersymmetric quantum mechanics constructed from this model has supersymmetry breaking or not. As below, we introduce the Dirac operator for fermion scattering on topological solitons in the nonlinear $O(3) \sigma$-model.

Let $\sigma_{j} \in M_{2}(\mathbb{C})$ be the Pauli matrices for $j=1,2,3$, that is,

\sigma_{1}=\left(\begin{array}{cc}
0 & 1 \\
1 & 0
\end{array}\right), \quad \sigma_{2}=\left(\begin{array}{cc}
0 & -i \\
i & 0
\end{array}\right), \quad \sigma_{3}=\left(\begin{array}{cc}
1 & 0 \\
0 & -1
\end{array}\right) .
$$

The spin matrices are defined by $\gamma_{j}=\left(i \sigma_{j}\right) \otimes 1_{2}$ for $j=1,2$ and $\gamma_{3}=\left(-\sigma_{3}\right) \otimes 1_{2}$, where $1_{d}$ is the $d \times d$ identity matrix. It is easy to verify that

- $\sigma_{j}^{2}=1_{2}$ for $j=1,2,3$ and also $\sigma_{1} \sigma_{2}=i \sigma_{3}, \sigma_{2} \sigma_{3}=i \sigma_{1}$ and $\sigma_{3} \sigma_{1}=i \sigma_{2}$;
- $\gamma_{j}^{2}=1_{4}$ for $j=1,2,3$ and also $\gamma_{1} \gamma_{2}=i \gamma_{3}, \gamma_{2} \gamma_{3}=-i \gamma_{1}$ and $\gamma_{3} \gamma_{1}=-i \gamma_{2}$;
- $\left\{\sigma_{j}, \sigma_{k}\right\}=0_{2}$ and $\left\{\gamma_{j}, \gamma_{k}\right\}=0_{4}$ for all $1 \leq j \neq k \leq 3$,
where $\{a, b\}=a b+b a$ and $0_{d}$ is the $d \times d$ zero matrix.
Denote by $\mathcal{N}$ the set of all vector fields $\boldsymbol{n}=\left(n_{1}, n_{2}, n_{3}\right)$ such that
$(\mathrm{n}-1) n_{j}$ is continuously differentiable a.e. $\mathbb{R}^{2}$ for $j=1,2,3$;
(n-2) $\|\boldsymbol{n}(\boldsymbol{x})\|=1$ a.e. $\boldsymbol{x} \in \mathbb{R}^{2}$;
(n-3) $D_{k} n_{j}$ is bounded a.e. $\mathbb{R}^{2}$ for all $j=1,2,3$ and $k=1,2$;
(n-4) $\lim _{\|\boldsymbol{x}\| \rightarrow \infty}\left\|\nabla n_{j}(\boldsymbol{x})\right\|=0$ for $j=1,2,3$,
where $\|\cdot\|$ is the standard Euclidian distance and $D_{j}$ is the generalized partial differential operator in the variable $x_{j}$, and also $\nabla=\left(D_{1}, D_{2}\right)$ is a (generalized) gradient. Due to condition (n-2), which asserts that $\sup _{\boldsymbol{x} \in \mathbb{R}^{2}}\left|n_{j}(\boldsymbol{x})\right| \leq 1$, the function $n_{j}$ can be considered a bounded multiplication operator

[^0]on $L^{2}\left(\mathbb{R}^{2}\right)$. Additionally, in accordance with condition (n-3), the operator $D_{k} n_{j}$ can also be viewed as a bounded multiplication operator on $L^{2}\left(\mathbb{R}^{2}\right)$ for $j=1,2,3$ and $k=1,2$.

Definition 1.1 ([6]). A Dirac operator for fermion scattering on topological solitons in the nonlinear $O(3) \sigma$-model (for short, fermionic Dirac operator) is a linear operator on $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{4}\right) \otimes \mathbb{C}^{2}$ defined by

H_{\text {ferm }} \equiv H_{\text {ferm }}(\boldsymbol{n}):=-i \sum_{k=1}^{2} \gamma_{3} \gamma_{k} D_{k} \otimes 1_{2}+m \sum_{j=1}^{3} \gamma_{3} n_{j} \otimes \tau_{j}
$$

for Yukawa coupling constant $m>0, \boldsymbol{n}=\left(n_{1}, n_{2}, n_{3}\right) \in \mathcal{N}$ and $\boldsymbol{\tau} \equiv\left(\tau_{1}, \tau_{2}, \tau_{3}\right):=\left(\sigma_{1}, \sigma_{2}, \sigma_{3}\right)$.
By the natural identification $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{4}\right) \otimes \mathbb{C}^{2} \cong \oplus_{i=1}^{2} L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}$, one can see that $H_{\text {ferm }}$ has the matrix representation $H_{\text {ferm }}=H \oplus H$, where $H$ is a linear operator on $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}$ as

$$
\begin{equation*}
H \equiv H(\boldsymbol{n}):=\left(-i \sigma_{2} D_{1}+i \sigma_{1} D_{2}\right) \otimes 1_{2}-m \sum_{j=1}^{3} \sigma_{3} n_{j} \otimes \tau_{j} . \tag{1.1}
\end{equation*}
$$

Since $H_{\text {ferm }}$ is diagonal, we have $\sigma\left(H_{\text {ferm }}\right)=\sigma(H)$. In the following, we use $H$ as the fermionic Dirac operator instead of $H_{\text {ferm }}$.

Denote by $\mathcal{C}=\{(r, \varphi): r>0,0 \leq \varphi<2 \pi\}$ the polar coordinate system and $\Phi: \mathcal{C} \rightarrow \mathbb{R}^{2}$ the polar coordinate conversion. A unitary operator $U: L^{2}\left(\mathbb{R}^{2}\right) \rightarrow L^{2}(\mathcal{C}, r \mathrm{~d} r \mathrm{~d} \varphi)$ defined by $U f=f \circ \Phi$ plays a role of the polar coordinate conversion for operators. Then we get the equivalence of operators:

H(\boldsymbol{n}) \simeq \widetilde{H}(\boldsymbol{n}):=\left(-i \sigma_{2} \widetilde{D_{1}}+i \sigma_{1} \widetilde{D_{2}}\right) \otimes 1_{2}-m \sum_{j=1}^{3} \sigma_{3} \widetilde{n_{j}} \otimes \tau_{j}
$$

with respect to the unitary conjugation by $U \otimes 1_{2}$, where $\widetilde{n_{j}}=U n_{j} U^{-1}$ for $j=1,2,3$ and

$$
\widetilde{D_{1}}=\cos \varphi \cdot \partial_{r}-\frac{\sin \varphi}{r} \cdot \partial_{\varphi}, \quad \text { and } \quad \widetilde{D_{2}}=\sin \varphi \cdot \partial_{r}+\frac{\cos \varphi}{r} \cdot \partial_{\varphi}
$$

see Sections 3.1 and 3.2 for more details. By the unitary invariance of spectrums, we have $\sigma(H(\boldsymbol{n}))=$ $\sigma(\widetilde{H}(\boldsymbol{n})), \sigma_{\mathrm{d}}(H(\boldsymbol{n}))=\sigma_{\mathrm{d}}(\widetilde{H}(\boldsymbol{n}))$ and $\sigma_{\text {ess }}(H(\boldsymbol{n}))=\sigma_{\text {ess }}(\widetilde{H}(\boldsymbol{n}))$, where $\sigma_{\mathrm{d}}(A)$ and $\sigma_{\text {ess }}(A):=\sigma(A) \backslash$ $\sigma_{\mathrm{d}}(A)$ are discrete and essential spectrums of an operator $A$, respectively. Especially, we are interested in the Dirac operator $H(\boldsymbol{n}) \simeq \widetilde{H}(\boldsymbol{n})$ when a vector field $\boldsymbol{n}$ is the hedgehog-ansatz $\boldsymbol{n}(F)$, that is, for $\omega=(r, \varphi) \in \mathcal{C}$,

$$
\begin{equation*}
\widetilde{n_{1}}(\omega)=\sin F(r) \cos N \varphi, \quad \widetilde{n_{2}}(\omega)=\sin F(r) \sin N \varphi, \quad \widetilde{n_{3}}(\omega)=\cos F(r), \tag{1.2}
\end{equation*}
$$

where $N \in \mathbb{Z}$ and $F:(0, \infty) \rightarrow[0, \pi]$ is a function that is continuously differentiable and subjects to specific boundary conditions. The function $F$ is called a profile function.

In nuclear physics and quantum field theory, the notion of ground states is significantly important in elucidating the lowest energy of the Hamiltonian (Dirac operator) in a quantum mechanical system. Rigorously, a ground state of a self-adjoint operator $T$ bounded from below is defined as a nonzero eigenvector in $\operatorname{ker}\left(T-E_{0}(T)\right)$, where $E_{0}(T):=\inf \sigma(T)$ denotes the lowest energy of $T$. Notably, as $H(\boldsymbol{n})^{2}$ is positive, its lowest energy $E_{0}\left(H(\boldsymbol{n})^{2}\right)$ is grater than or equal to zero. In Proposition 2.4, we prove that $\sigma_{\text {ess }}(H(\boldsymbol{n}))=(-\infty,-m] \cup[m, \infty)$ holds true for all vector fields $\boldsymbol{n} \in \mathcal{N}$, consequently implying $\sigma_{\text {ess }}\left(H(\boldsymbol{n})^{2}\right)=\left[m^{2}, \infty\right)$ and $\sigma_{\mathrm{d}}\left(H(\boldsymbol{n})^{2}\right) \subset\left[0, m^{2}\right)$. From diverse perspectives such as nuclear physics, quantum mechanics and condensed matter physics, it is concerned whether $E_{0}\left(H(\boldsymbol{n})^{2}\right)$ belongs to the discrete spectrum $\sigma_{\mathrm{d}}\left(H(\boldsymbol{n})^{2}\right)$. As an interest of purely mathematics, the similar type
problem has already studied (see [3, 4]; the existence of discrete ground states of Dirac operators in the chiral quark soliton model). Here, we introduce the notion of discrete ground states.

Definition 1.2. Let $T$ be a self-adjoint operator bounded from below. If $E_{0}(T) \in \sigma_{\mathrm{d}}(T)$, then a non-zero vector in $\operatorname{ker}\left(T-E_{0}(T)\right)$ is called a discrete ground state of $T$. In addition, we denote by $E_{0}^{+}(T)=\inf (\sigma(T) \cap[0, \infty))$ and $E_{0}^{-}(T)=\sup (\sigma(T) \cap(-\infty, 0])$. If $E_{0}^{+}(T) \in \sigma_{\mathrm{d}}(T)$ (resp. $E_{0}^{-}(T) \in$ $\left.\sigma_{\mathrm{d}}(T)\right)$, then a non-zero vector in $\operatorname{ker}\left(T-E_{0}^{+}(T)\right)\left(\right.$ resp. $\left.\operatorname{ker}\left(T-E_{0}^{-}(T)\right)\right)$ is called a discrete positive (resp. negative) energy ground state of $T$.

In this paper, we firstly establish sufficient conditions for the existence of discrete energy ground states for the fermionic Dirac operator $H(\boldsymbol{n}(F))$ with a hedgehog-ansatz. These conditions provide insights into the stability and nature of the solutions associated with the model. To derive sufficient conditions, our attention is directed towards the reduced component $H(\ell, s, t)$ of the Dirac operator $H(\boldsymbol{n}(F))$. Specifically, we focus on its action within an eigenspace of the grand spin operator $K_{3}$, characterized by an eigenvalue of the form $\ell+\frac{s}{2}+\frac{N t}{2}$, where $\ell$ is an integer, and $s$ and $t$ take values of $\pm 1$. By scrutinizing the operator $H(\ell, s, t)^{2}$, our first main theorem is established.

Theorem 1.3. Let us consider a profile function $F$. If there exist $\ell \in \mathbb{Z}$ and $t \in\{1,-1\}$ such that

\inf _{\substack{\left.f \in C_{\infty}^{\infty}(0, \infty)\right) \\\|f\|_{2}=1}}\left\langle f,\left(-\frac{\mathrm{d}^{2}}{\mathrm{~d} r^{2}}-\frac{1}{r} \frac{\mathrm{~d}}{\mathrm{~d} r}+\frac{\ell^{2}+(\ell+1)^{2}}{2 r^{2}}+m t \frac{\mathrm{~d} F}{\mathrm{~d} r} \sin F\right) f\right\rangle_{2}<0,
$$

then $H(\boldsymbol{n}(F))$ has a discrete positive or negative energy ground state, where $C_{0}^{\infty}((0, \infty))$ is the set of all compactly supported $C^{\infty}$-functions on $(0, \infty)$ and

$$
\langle u, v\rangle_{2}:=\int_{(0, \infty)} \overline{u(r)} v(r) r \mathrm{~d} r \quad \text { and } \quad\|u\|_{2}:=\sqrt{\langle u, u\rangle_{2}}
$$

for all $u, v \in L^{2}((0, \infty), r \mathrm{~d} r)$.
A strategy of proof is to use the min-max principle as well as [3] and [4]. However, the choice of vectors in the eigenspace of the grand spin operator $K_{3}$ is quite different from the previous works, see Lemma 4.1 for details.

The Dirac operator $H=H(\boldsymbol{n})$ is employed to construct a supersymmetric quantum mechanics denoted as a quadruple $\left\{L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}, H^{2}, H, \Gamma\right\}$, in which $\Gamma$ is a unitary and selfadjoint operator on $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}$ satisfying the condition $\{H, \Gamma\}=0$. The supersymmetry is a theoretical concept in physics denoting a symmetry between bosons and fermions. The subsequent goal in the paper is to establish a sufficient condition for the supersymmetric quantum mechanics associated with the fermionic Dirac operator $H$, to exhibit supersymmetry (SUSY) breaking. To elaborate further, the SUSY breaking means the absence of zero-energy states in the spectrum of the Dirac operator $H$, i.e. $\operatorname{Ker} H=\{0\}$. Actually, we will find a sufficient condition to be $E_{0}\left(H^{2}\right)>0$, which implies that $\operatorname{Ker} H=\{0\}$.
Theorem 1.4. Let $\boldsymbol{n}=\boldsymbol{n}(F)$ be the hedgehog-ansatz with $\lim \sup _{r \rightarrow 0^{+}}\left|\frac{\sin F(r)}{r}\right|<\infty$. If

$$
m>\sup _{r>0} \sqrt{\left|F^{\prime}(r)^{2}-\left(\frac{N}{r} \sin F(r)\right)^{2}\right|},
$$

then the supersymmetric quantum mechanics $\left\{L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}, H^{2}, H, \Gamma\right\}$ is SUSY breaking, where $\Gamma$ is a unitary self-adjoint operator defined in Lemma 5.1.

Note that, if $H$ has no discrete energy ground states, then $\left\{L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}, H^{2}, H, \Gamma\right\}$ is automatically SUSY breaking. From the reason, we are interested in the supersymmetric quantum mechanics $\left\{L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}, H^{2}, H, \Gamma\right\}$ in which $H$ has a discrete energy ground state and this mechanics is SUSY breaking. Finally, we give the expected example as above (see Example 5.5).

The present paper is organized as follows: In Section 2, we derive into the general spectral properties of the fermionic Dirac operators. Specifically, our focus is on investigating the essential and discrete spectrums of $H(\boldsymbol{n})$. In Section 3, we explain a basic theory for differentiable operators via the polar coordinate conversion. Furthermore, we introduce and study the fermionic Dirac operators with the hedgehog-ansatz. In Section 4, we rigorously prove the first main theorem (i.e. Theorem [1.3). In section 5, we establish the class of unitary and selfadjoint operators $\xi$ on $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right)$ such that a quadruple $\left\{L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}, H^{2}, H, \sigma_{3} \otimes \xi\right\}$ embodies the supersymmetric quantum mechanics (see Lemma 5.1). Finally, we provide a sufficient condition for the SUSY breaking of this quantum mechanics (i.e. Theorem (1.4) and we give these examples (see Example 5.5).

## 2. Construction of spectrum

In this section, we denote $H$ as the operator $H(\boldsymbol{n})$ defined in (1.1) as the specific vector fields $\boldsymbol{n}$ under consideration are unimportant. We explore the spectral properties of the fermionic Dirac operator $H$.

We denote by $H_{0}:=\left(-i \sigma_{2} D_{1}+i \sigma_{1} D_{2}\right) \otimes 1_{2}$ the spin-Dirac operator. It is known that $H_{0}$ is a self-adjoint operator on $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}$. Since the operator $m \sum_{j=1}^{3} \sigma_{3} n_{j} \otimes \tau_{j}$ is bounded and selfadjoint, it follows from the Kato-Rellich theorem (see e.g. [10, Theorem X.12]) that $\mathcal{D}(H)=\mathcal{D}\left(H_{0}\right)$ and $H=H_{0}-m \sum_{j=1}^{3} \sigma_{3} n_{j} \otimes \tau_{j}$ is self-adjoint. Therefore $\sigma(H)$ is contained in $\mathbb{R}$. Furthermore, the symmetry of $\sigma(H)$ is established.

Lemma 2.1. The spectrum $\sigma(H)$ is symmetric with respect to zero, that is, $\lambda \in \sigma(H)$ implies that $-\lambda \in \sigma(H)$. Moreover, so are $\sigma_{\mathrm{d}}(H)$ and $\sigma_{\text {ess }}(H)$.

Proof. Define an operator $\Gamma:=\sigma_{3} \otimes \xi$ on $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}$, where $\xi$ is a unitary self-adjoint operator on $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right.$ ) such that $\{\xi, \boldsymbol{n} \cdot \boldsymbol{\tau}\}=0$ (see Example 5.2 for the existence of $\xi$ ). It is easy to see that $\Gamma$ is also a self-adjoint and unitary operator. Moreover, we obtain $\Gamma \mathcal{D}(H)=\mathcal{D}(H)$. A direct calculation shows that $\{\Gamma, H\}=0$ on $\mathcal{D}(H)$ (or see Lemma 5.1). By the relation between $\Gamma$ and $H$, and also unitarity of $\Gamma$, we get $\sigma(H)=\sigma\left(\Gamma(-H) \Gamma^{-1}\right)=\sigma(-H)$, as desired. A similar argument to the above proof shows that $\sigma_{\text {ess }}(H)$ and $\sigma_{\mathrm{d}}(H)$ are also symmetric with respect to zero.

Lemma 2.2. For any $\boldsymbol{n}=\left(n_{1}, n_{2}, n_{3}\right) \in \mathcal{N}$, we have

$$
H^{2}=\left(-\Delta+m^{2}\right) 1_{2} \otimes 1_{2}-m \sum_{j=1}^{3}\left(\sum_{k=1}^{2} \sigma_{k}\left(D_{k} n_{j}\right)\right) \otimes \tau_{j}
$$

where $\Delta:=D_{1}^{2}+D_{2}^{2}$ denotes the 2-dimensional Laplacian.

Proof. A direct computation shows

$$
\begin{aligned}
H^{2}= & \left(i \sigma_{2} D_{1} \otimes 1_{2}\right)^{2}+\left(i \sigma_{1} D_{2} \otimes 1_{2}\right)^{2}+m^{2}\left(\sum_{j=1}^{3} \sigma_{3} n_{j} \otimes \tau_{j}\right)^{2} \\
& +\underbrace{\left\{\sigma_{2} D_{1}, \sigma_{1} D_{2}\right\}}_{=0} \otimes 1_{2}+i m \sum_{j=1}^{3}\left\{\sigma_{2} D_{1}, \sigma_{3} n_{j}\right\} \otimes \tau_{j}-i m \sum_{j=1}^{3}\left\{\sigma_{1} D_{2}, \sigma_{3} n_{j}\right\} \otimes \tau_{j} \\
= & \left(-\Delta+m^{2}\right) 1_{2} \otimes 1_{2}+i m \sum_{j=1}^{3} \underbrace{\sigma_{2} \sigma_{3}}_{=i \sigma_{1}}\left(D_{1} n_{j}\right) \otimes \tau_{j}-i m \sum_{j=1}^{3} \underbrace{\sigma_{1} \sigma_{3}}_{=-i \sigma_{2}}\left(D_{2} n_{j}\right) \otimes \tau_{j} \\
= & \left(-\Delta+m^{2}\right) 1_{2} \otimes 1_{2}-m \sum_{j=1}^{3}\left(\sum_{k=1}^{2} \sigma_{k}\left(D_{k} n_{j}\right)\right) \otimes \tau_{j} .
\end{aligned}
$$

For simply, we write $-\Delta+m^{2}$ as $\left(-\Delta+m^{2}\right) 1_{2} \otimes 1_{2}$. Here, we define

$$
V \equiv V(\boldsymbol{n}):=-m \sum_{j=1}^{3}\left(\sum_{k=1}^{2} \sigma_{k}\left(D_{k} n_{j}\right)\right) \otimes \tau_{j}
$$

By the definition of $\tau_{j}$ 's, one can see the following matrix decomposition of $V$.
Lemma 2.3. The operator $V$ has

$$
V=\left(\begin{array}{cc}
0 & W^{*} \\
W & 0
\end{array}\right)
$$

where $W \equiv W(\boldsymbol{n}):=-m \sum_{j=1}^{3}\left(\left(D_{1} n_{j}\right)+i\left(D_{2} n_{j}\right)\right) \otimes \tau_{j}$.
Further, we define

$$
\begin{equation*}
L \equiv L(\boldsymbol{n}):=-\Delta+V \tag{2.1}
\end{equation*}
$$

Then $H^{2}$ is written by $H^{2}=L+m^{2}$. Since $V$ is a bounded and self-adjoint operator, $L$ is self-adjoint and $\mathcal{D}(L)=\mathcal{D}(-\Delta)$ by Kato-Rellich theorem. Finally, we derive a construction of $\sigma_{\text {ess }}(H)$ and $\sigma_{\mathrm{d}}(H)$.

Proposition 2.4. We have $\sigma_{\text {ess }}(H)=(-\infty,-m] \cup[m, \infty)$ and $\sigma_{\mathrm{d}}(H) \subset(-m, m)$.
Proof. By [5, Theorem 6.7] and two assumptions (n-3) and (n-4), the operator $V$ is compact. Since $\sigma(-\Delta)=\sigma_{\text {ess }}(-\Delta)=[0, \infty)$, we get $\sigma_{\text {ess }}(L)=\sigma_{\text {ess }}(-\Delta)=[0, \infty)$ by the Weyl theorem (see e.g. [9, Example 3, Page 117]). Finally, $\sigma_{\text {ess }}\left(H^{2}\right)=\left[m^{2}, \infty\right)$, and hence it follows that $\sigma_{\text {ess }}(H)=(-\infty,-m] \cup$ $[m, \infty)$.

## 3. Hedgehog-ansatz

3.1. Differential operators under the polar coordinate conversion. Suppose the polar coordinate conversion $\Phi: \mathcal{C} \rightarrow \mathbb{R}^{2}$, that is, $\Phi(\omega):=(r \cos \varphi, r \sin \varphi)$ for $\omega=(r, \varphi) \in \mathcal{C}$. The map $\Phi$ is injective and $\Phi(\mathcal{C})=\mathbb{R}^{2} \backslash\{(0,0)\}$. For a complex valued function $f$ on domain which contains $\Phi(\mathcal{C})$ and $\omega \in \mathcal{C}$, we define $\widetilde{f}(\omega):=f(\Phi(\omega))$. Then for any $\psi \in L^{2}\left(\mathbb{R}^{2}\right)$, we have

$$
\int_{\mathbb{R}^{2}}|\psi(\boldsymbol{x})|^{2} \mathrm{~d} \boldsymbol{x}=\int_{\Phi(\mathcal{C})}|\psi(\boldsymbol{x})|^{2} \mathrm{~d} \boldsymbol{x}=\int_{\mathcal{C}}|\widetilde{\psi}(\omega)|^{2} r \mathrm{~d} r \mathrm{~d} \varphi,
$$

and therefore the isometry $U: L^{2}\left(\mathbb{R}^{2}\right) \rightarrow L^{2}(\mathcal{C}, r \mathrm{~d} r \mathrm{~d} \varphi)$ can be defined by $U \psi=\tilde{\psi}$ for all $\psi \in L^{2}\left(\mathbb{R}^{2}\right)$. The operator $U$ is unitary. For $\left(x_{1}, x_{2}\right) \in \mathbb{R}^{2} \backslash\{(0,0)\}$, it is easy to see that $U x_{1} U^{-1}=r \cos \varphi$ and $U x_{2} U^{-1}=r \sin \varphi$, where $x_{j}$ is regarded as a multiplication operator on $L^{2}\left(\mathbb{R}^{2}\right)$ for $j=1,2$. By the definition of cylindrical coordinate conversion and the chain rule of partial differential, we see that

$$
U D_{1} U^{-1}=\cos \varphi \cdot \partial_{r}-\frac{\sin \varphi}{r} \cdot \partial_{\varphi} \quad \text { and } \quad U D_{2} U^{-1}=\sin \varphi \cdot \partial_{r}+\frac{\cos \varphi}{r} \cdot \partial_{\varphi},
$$

on $U\left(\bigcap_{j=1}^{2} \mathcal{D}\left(D_{j}\right)\right)$, where $\partial_{\#}$ is a partial differential operator in the variable $\#=r, \varphi$.
By the above relation, we have $\widetilde{\Delta}:=U \Delta U^{-1}=\partial_{r}^{2}+\frac{1}{r} \partial_{r}+\frac{1}{r^{2}} \partial_{\varphi}^{2}$ on $U\left[\mathcal{D}(\Delta) \cap C^{2}(\Phi(\mathcal{C}))\right]$. The unitary invariance implies $\sigma(-\widetilde{\Delta})=\sigma_{\text {ess }}(-\widetilde{\Delta})=[0, \infty)$.
3.2. Hedgehog-ansatz. Consider $N \in \mathbb{Z}$. Define a vector field $\boldsymbol{n}(F)=\left(n_{1}, n_{2}, n_{3}\right)$, where $n_{j}$ are defined in (1.2) and $F:(0, \infty) \rightarrow[0, \pi]$ is a function such that
(F-1) $F$ is continuously differentiable on $(0, \infty)$;
(F-2) $\sup _{r>0}\left|F^{\prime}(r)\right|<\infty$ and $F^{\prime} \not \equiv 0$ on $(0, \infty)$;
(F-3) $\lim _{r \rightarrow \infty} F^{\prime}(r)=0$.
Define $\mathcal{F}=\{F:(0, \infty) \rightarrow[0, \pi]: F$ satisfies the conditions (F-1) - (F-3) $\}$. For $F \in \mathcal{F}$ and $N \in \mathbb{Z}$, the vector field $\boldsymbol{n}(F)$ is called the hedgehog-ansat ${ }^{1}$.

Lemma 3.1. For any $F \in \mathcal{F}$, we have $\boldsymbol{n}(F) \in \mathcal{N}$.
Proof. Since $n_{j}=U^{-1} \widetilde{n}_{j} U$ on $\Phi(\mathcal{C})$ for $j=1,2,3$, we get $n_{1}(\boldsymbol{x})=\sin F\left(\sqrt{x_{1}^{2}+x_{2}^{2}}\right) \cdot \cos \left(N \operatorname{Tan}^{-1}\left(x_{2} / x_{1}\right)\right)$, $n_{2}(\boldsymbol{x})=\sin F\left(\sqrt{x_{1}^{2}+x_{2}^{2}}\right) \cdot \sin \left(N \operatorname{Tan}^{-1}\left(x_{2} / x_{1}\right)\right)$ and $n_{3}(\boldsymbol{x})=\cos F\left(\sqrt{x_{1}^{2}+x_{2}^{2}}\right)$ for all $\boldsymbol{x} \in \Phi(\mathcal{C})$. By the assumptions (F-1) and (F-2), $n_{j}$ is continuously differentiable and $D_{k} n_{j}$ is bounded on $\Phi(\mathcal{C})$ for $j=1,2,3$ and $k=1,2$. It is easy to see that $\|\boldsymbol{n}(F)(\boldsymbol{x})\|=1$ on $\Phi(\mathcal{C})$. By the chain rule of the partial differential, for $\omega=(r, \varphi) \in \mathcal{C}$, we have

$$
\frac{\partial \widetilde{n}_{1}}{\partial r}(\omega)=\frac{\partial n_{1}}{\partial r}(r \cos \varphi, r \sin \varphi)=\frac{\partial n_{1}}{\partial x_{1}} \frac{\partial x_{1}}{\partial r}+\frac{\partial n_{1}}{\partial x_{2}} \frac{\partial x_{2}}{\partial r}=\frac{\partial n_{1}}{\partial x_{1}} \cos \varphi+\frac{\partial n_{1}}{\partial x_{2}} \sin \varphi .
$$

Since $\widetilde{n}_{1}(r, \varphi)=\sin F(r) \cos N \varphi$, it follows from the assumption (F-3) that

$$
\frac{\partial \widetilde{n}_{1}}{\partial r}(\omega)=F^{\prime}(r) \cos F(r) \cos N \varphi \rightarrow 0, \quad r \rightarrow \infty
$$

Therefore we obtain $D_{1} n_{1}(\boldsymbol{x}) \rightarrow 0$ and $D_{2} n_{1}(\boldsymbol{x}) \rightarrow 0$ as $\|\boldsymbol{x}\| \rightarrow \infty$. Finally, we get $\left\|\nabla n_{1}(\boldsymbol{x})\right\| \rightarrow 0$ as $\|\boldsymbol{x}\| \rightarrow \infty$. Similarly, we obtain $\left\|\nabla n_{2}(\boldsymbol{x})\right\| \rightarrow 0$ as $\|\boldsymbol{x}\| \rightarrow \infty$. Therefore $\boldsymbol{n}(F) \in \mathcal{N}$.

For an operator $A$ on $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}$, we define the operator $\widetilde{A}$ on $L^{2}\left(\mathcal{C} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}$ by

$$
\widetilde{A}:=\left(U \otimes 1_{2}\right) A\left(U \otimes 1_{2}\right)^{-1}
$$

where we use the same symbol $\widetilde{A}$ as in the unitary conjugation by $U: L^{2}\left(\mathbb{R}^{2}\right) \rightarrow L^{2}(\mathcal{C}, r \mathrm{~d} r \mathrm{~d} \varphi)$. Consider $H \equiv H(\boldsymbol{n}(F))$, $V \equiv V(\boldsymbol{n}(F))$ and $L \equiv L(\boldsymbol{n}(F))$ for $F \in \mathcal{F}$ as below. By Lemma 3.1 and Theorem [2.4, we have $\sigma_{\mathrm{d}}(\widetilde{H})=\sigma_{\mathrm{d}}(H) \subset(-m, m)$. By Lemma [2.2, we have $\widetilde{H}^{2}=\widetilde{L}+m^{2}=$ $-\widetilde{\Delta}+\widetilde{V}+m^{2}$, where

$$
\widetilde{V}=\left(\begin{array}{cc}
0 & m \sum_{j=1}^{3} e^{-i \varphi}\left(\frac{\partial \widetilde{\varkappa_{j}}}{\partial r}-\frac{i}{r} \frac{\partial \widetilde{n_{j}}}{\partial \varphi}\right) \otimes \tau_{j} \\
-m \sum_{j=1}^{3} e^{i \varphi}\left(\frac{\partial \widetilde{n_{j}}}{\partial r}+\frac{i}{r} \frac{\partial \widetilde{n_{j}}}{\partial \varphi}\right) \otimes \tau_{j} & 0
\end{array}\right) .
$$

[^1]3.3. Reduced part with respect to the grand spin. Let $L_{3}=\overline{-i x_{1} D_{2}+i x_{2} D_{1}}$ be the third component of the angular momentum. Define the grand spin $K_{3}=L_{3} \otimes 1_{2}+\frac{1}{2} \sigma_{3} \otimes 1_{2}+\frac{N}{2} \otimes \tau_{3}$. Note that $K_{3}$ is a self-adjoint operator on $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}$. By [4, (5.16)],
$$
\sigma\left(K_{3}\right)=\sigma_{\mathrm{p}}\left(K_{3}\right)=\left\{\ell+\frac{s}{2}+\frac{N t}{2}: \ell \in \mathbb{Z}, s, t \in\{1,-1\}\right\},
$$
where $\sigma_{\mathrm{p}}(A)$ is the point spectrum of $A$. By [4, (5.17)], the eigenspace of $K_{3}$ with an eigenvalue $\ell+(s / 2)+(N t / 2)$ is given by $\mathcal{M}_{\ell, s, t}:=\operatorname{ker}\left(L_{3}-\ell\right) \otimes \operatorname{ker}\left(\sigma_{3}-s\right) \otimes \operatorname{ker}\left(\tau_{3}-t\right)$. Therefore $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}$ has the following orthogonal decomposition $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2} \cong \bigoplus_{\ell \in \mathbb{Z}, s, t \in\{ \pm 1\}} \mathcal{M}_{\ell, s, t}$, under the natural identification $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2} \cong L^{2}\left(\mathbb{R}^{2}\right) \otimes \mathbb{C}^{2} \otimes \mathbb{C}^{2}$.

Lemma $3.2(6])$. Consider $H \equiv H(\boldsymbol{n}(F))$ for $F \in \mathcal{F}$.
(1) The operators $H$ and $K_{3}$ strongly commute, that is, their spectral projections commute.
(2) For any $\Psi \in \mathcal{D}(H)$, we obtain $P_{\mathcal{M}_{\ell, s, t}} \Psi \in \mathcal{D}(H)$ and $H P_{\mathcal{M}_{\ell, s, t}} \Psi=P_{\mathcal{M}_{\ell, s, t}} H \Psi$, where $P_{\mathcal{M}_{\ell, s, t}}$ is a projection onto $\mathcal{M}_{\ell, s, t}$.

Proof. The first statement can be proven using a similar approach as outlined in [4, Lemmas 5.2 and 5.3]. The second statement follows readily from the first one.

By Lemma 3.2, one can define the reduced part $H(\ell, s, t)$ of $H$ to $\mathcal{M}_{\ell, s, t}$, that is, $H(\ell, s, t):=$ $H \upharpoonright_{\mathcal{D}(H(\ell, s, t))}$, where $\mathcal{D}(H(\ell, s, t))=\mathcal{D}(H) \cap \mathcal{M}_{\ell, s, t}$. Note that $\mathcal{D}(\widetilde{H}(\ell, s, t))=\mathcal{D}(\widetilde{H}) \cap \widetilde{\mathcal{M}}_{\ell, s, t}$, where $\widetilde{\mathcal{M}}_{\ell, s, t}:=\operatorname{ker}\left(-i \partial_{\varphi}-\ell\right) \otimes \operatorname{ker}\left(\sigma_{3}-s\right) \otimes \operatorname{ker}\left(\tau_{3}-t\right)$. Since $U L_{3} U^{-1}=-i \partial_{\varphi}$, we get $-\frac{\partial^{2}}{\partial \varphi^{2}} \upharpoonright_{\mathcal{D}(\widetilde{H}(\ell, s, t))}=\ell^{2}$, and therefore $\widetilde{\Delta} \upharpoonright_{\mathcal{D}(\widetilde{H}(\ell, s, t))}=\frac{\mathrm{d}^{2}}{\mathrm{~d} r^{2}}+\frac{1}{r} \frac{\mathrm{~d}}{\mathrm{~d} r}-\frac{\ell^{2}}{r^{2}}$. In the following, we denote by

$$
\Delta_{\ell}:=\frac{\mathrm{d}^{2}}{\mathrm{~d} r^{2}}+\frac{1}{r} \frac{\mathrm{~d}}{\mathrm{~d} r}-\frac{\ell^{2}}{r^{2}}, \quad \ell \in \mathbb{R}
$$

Moreover, for any $F \in \mathcal{F}$, we get

$$
\widetilde{V} \upharpoonright_{\mathcal{D}(\widetilde{H}(\ell, s, t))} \equiv \widetilde{V}(\boldsymbol{n}(F)) \upharpoonright_{\mathcal{D}(\widetilde{H}(\ell, s, t))}=\left(\begin{array}{cc}
0 & W(t)^{*} \\
W(t) & 0
\end{array}\right),
$$

where

$$
(W(t) \Psi)(\omega):=-m e^{i \varphi}\left\{\sum_{j=1}^{2}\left(\frac{\partial \widetilde{n_{j}}}{\partial r}+\frac{i}{r} \frac{\partial \widetilde{n_{j}}}{\partial \varphi}\right) \otimes \tau_{j}+t \frac{\partial \widetilde{n_{3}}}{\partial r} \otimes 1_{2}\right\} \Psi(\omega)
$$

for any $\Psi \in \mathcal{D}(W(t))$ and $\omega=(r, \varphi) \in \mathcal{C}$. Finally, we get

$$
\widetilde{H}(\ell, s, t)^{2}=\underbrace{-\Delta_{\ell}+\left(\begin{array}{cc}
0 & W(t)^{*} \\
W(t) & 0
\end{array}\right)}_{=: L(\ell, t)}+m^{2}
$$

on $C_{0}^{\infty}((0, \infty))$. Note that $L(\ell, t)=\widetilde{L} \upharpoonright_{\mathcal{D}(\widetilde{H}(\ell, s, t))}$ and $\sigma_{\text {ess }}(L(\ell, t)) \subset[0, \infty)$.

## 4. Existence of discrete ground states

In this section, we establish sufficient conditions for that $H \equiv H(\boldsymbol{n}(F))$ has a discrete positive or negative energy ground state (see Theorems 1.3 and 1.4). For after discussions, we denote by

$$
v_{\ell}(f)(\omega)=f(r) e^{i \ell \varphi}
$$

for all $\omega=(r, \varphi) \in \mathcal{C}$ and complex-valued functions $f$ on $(0, \infty)$ and $\ell \in \mathbb{Z}$. Let $u_{t} \in \mathbb{C}^{2}$ be an eigenvector of $\tau_{3}$ for each $t \in\{1,-1\}$, that is, $\tau_{3} u_{t}=t u_{t}$ for each $t \in\{1,-1\}$. Further, we consider $\ell \in \mathbb{Z}$ and unit vectors $f \in C_{0}^{\infty}((0, \infty))$. We then define the following vectors:

$$
\Psi_{f,+}^{(\ell, t)}=\left(v_{\ell}(f) \otimes u_{t}, 0\right)^{\top} \in \widetilde{\mathcal{M}}_{\ell, 1, t} \quad \text { and } \quad \Psi_{f,-}^{(\ell, t)}=\left(0, v_{\ell}(f) \otimes u_{t}\right)^{\top} \in \widetilde{\mathcal{M}}_{\ell,-1, t} .
$$

Moreover, for $\ell_{1}, \ell_{2} \in \mathbb{Z}$ and $t \in\{1,-1\}$, we define $\Psi_{f}^{\left(\ell_{1}, \ell_{2}, t\right)}:=\frac{1}{\sqrt{2}}\left(\Psi_{f,+}^{\left(\ell_{1}, t\right)}+\Psi_{f,-}^{\left(\ell_{2}, t\right)}\right)$.
Lemma 4.1. Let us consider $\ell_{1}, \ell_{2} \in \mathbb{Z}, t \in\{1,-1\}$ and a unit vector $f \in C_{0}^{\infty}((0, \infty))$. Moreover, $\widetilde{V} \equiv \widetilde{V}(\boldsymbol{n}(F))$ for $F \in \mathcal{F}$. Then we obtain the following formula.
(1) $\left\langle\Psi_{f}^{\left(\ell_{1}, \ell_{2}, t\right)}, \widetilde{\Delta} \Psi_{f}^{\left(\ell_{1}, \ell_{2}, t\right)}\right\rangle=\frac{1}{2} \sum_{k=1}^{2}\left\langle f, \Delta_{\ell_{k}} f\right\rangle_{2}$.
(2) $\left\langle\Psi_{f}^{\left(\ell_{1}, \ell_{2}, t\right)}, \widetilde{V} \Psi_{f}^{\left(\ell_{1}, \ell_{2}, t\right)}\right\rangle=m t\left\langle f,\left(F^{\prime} \sin F\right) f\right\rangle_{2} \delta_{\ell_{1}+1, \ell_{2}}$

Proof. (1) Since $\left\langle\Psi_{f,+}^{\left(\ell_{1}, t\right)}, \widetilde{\Delta} \Psi_{f,-}^{\left(\ell_{2}, t\right)}\right\rangle=\left\langle\Psi_{f,-}^{\left(\ell_{2}, t\right)}, \widetilde{\Delta} \Psi_{f,+}^{\left(\ell_{1}, t\right)}\right\rangle=0$, we obtain

$$
\begin{aligned}
\left\langle\Psi_{f}^{\left(\ell_{1}, \ell_{2}, t\right)}, \widetilde{\Delta} \Psi_{f}^{\left(\ell_{1}, \ell_{2}, t\right)}\right\rangle & =\frac{1}{2}\left(\left\langle\Psi_{f,+}^{\left(\ell_{1}, t\right)}, \widetilde{\Delta} \Psi_{f,+}^{\left(\ell_{1}, t\right)}\right\rangle+\left\langle\Psi_{f,-}^{\left(\ell_{2}, t\right)}, \widetilde{\Delta} \Psi_{f,-}^{\left(\ell_{2}, t\right)}\right\rangle\right) \\
& =\frac{1}{2}\left(\left\langle\Psi_{f,+}^{\left(\ell_{1}, t\right)}, \Delta_{\ell_{1}} \Psi_{f,+}^{\left(\ell_{1}, t\right)}\right\rangle+\left\langle\Psi_{f,-}^{\left(\ell_{2}, t\right)}, \Delta_{\ell_{2}} \Psi_{f,-}^{\left(\ell_{2}, t\right)}\right\rangle\right) \\
& =\frac{1}{2}\left(\left\langle f, \Delta_{\ell_{1}} f\right\rangle_{2}+\left\langle f, \Delta_{\ell_{2}} f\right\rangle_{2}\right) .
\end{aligned}
$$

(2) We have

\begin{aligned}
\left\langle\Psi_{f,+}^{\left(\ell_{1}, t\right)}, \widetilde{V} \Psi_{f,+}^{\left(\ell_{1}, t\right)}\right\rangle & =\left\langle\binom{ v_{\ell_{1}}(f) \otimes u_{t}}{0},\left(\begin{array}{cc}
0 & W(t)^{*} \\
W(t) & 0
\end{array}\right)\binom{v_{\ell_{1}}(f) \otimes u_{t}}{0}\right\rangle \\
& =\left\langle\binom{ v_{\ell_{1}}(f) \otimes u_{t}}{0},\binom{0}{W(t)\left(v_{\ell_{1}}(f) \otimes u_{t}\right)}\right\rangle \\
& =0 .
\end{aligned}
$$

Similarly, we obtain $\left\langle\Psi_{f,-}^{\left(\ell_{2}, t\right)}, \widetilde{V} \Psi_{f,-}^{\left(\ell_{2}, t\right)}\right\rangle=0$. Hence,

\left\langle\Psi_{f}^{\left(\ell_{1}, \ell_{2}, t\right)},\right. & \left.\widetilde{V} \Psi_{f}^{\left(\ell_{1}, \ell_{2}, t\right)}\right\rangle \\
& =\frac{1}{2}\left(\left\langle\Psi_{f,+}^{\left(\ell_{1}, t\right)}, \widetilde{V} \Psi_{f,-}^{\left(\ell_{2}, t\right)}\right\rangle+\left\langle\Psi_{f,-}^{\left(\ell_{2}, t\right)}, \widetilde{V} \Psi_{f,+}^{\left(\ell_{1}, t\right)}\right\rangle\right) \\
& =\frac{1}{2}\left(\left\langle v_{\ell_{1}}(f) \otimes u_{t}, W(t)^{*}\left(v_{\ell_{2}}(f) \otimes u_{t}\right)\right\rangle+\left\langle v_{\ell_{2}}(f) \otimes u_{t}, W(t)\left(v_{\ell_{1}}(f) \otimes u_{t}\right)\right\rangle\right) \\
& =\operatorname{Re}\left\langle W(t)\left(v_{\ell_{1}}(f) \otimes u_{t}\right), v_{\ell_{2}}(f) \otimes u_{t}\right\rangle \\
& =-m t \operatorname{Re}\left(\int_{0}^{2 \pi} e^{-i\left(1+\ell_{1}\right) \varphi} e^{i \ell_{2} \varphi} \cdot \frac{1}{2 \pi} \mathrm{~d} \varphi\right)\left(\int_{(0, \infty)} \frac{\mathrm{d} \cos F(r)}{\mathrm{d} r} \overline{f(r)} f(r) r \mathrm{~d} r\right) \\
& =m t\left\langle f,\left(F^{\prime} \sin F\right) f\right\rangle_{2} \delta_{\ell_{1}+1, \ell_{2}} .
\end{aligned}
$$

For $\ell \in \mathbb{Z}$, we define $c(\ell):=\sqrt{\frac{\ell^{2}+(\ell+1)^{2}}{2}}$ and

$$
R(\ell, t):=-\Delta_{c(\ell)}+m t \frac{\mathrm{~d} F}{\mathrm{~d} r} \sin F,
$$

acting on $L^{2}((0, \infty), r \mathrm{~d} r)$ with domain $\mathcal{D}(R(\ell, t)):=C_{0}^{\infty}((0, \infty))$.

Theorem 4.2 (Theorem 1.3). Let us consider $F \in \mathcal{F}$. If there exist $\ell \in \mathbb{Z}$ and $t \in\{1,-1\}$ such that

$$
\begin{equation*}
\mathcal{E}_{0}(R(\ell, t)):=\inf _{\substack{f \in C_{\infty}^{\infty}((0, \infty)) \\\|f\|_{2}=1}}\langle f, R(\ell, t) f\rangle_{2}<0, \tag{4.1}
\end{equation*}
$$

then $H$ has a discrete positive or negative energy ground state.
Proof. For any $\ell \in \mathbb{Z}, t \in\{1,-1\}$ and unit vectors $f \in C_{0}^{\infty}((0, \infty))$, we get

$$
\begin{aligned}
\left\langle\Psi_{f}^{(\ell, \ell+1, t)}, \widetilde{L}_{f}^{(\ell, \ell+1, t)}\right\rangle & =\left\langle\Psi_{f}^{(\ell, \ell+1, t)},-\widetilde{\Delta} \Psi_{f}^{(\ell, \ell+1, t)}\right\rangle+\left\langle\Psi_{f}^{(\ell, \ell+1, t)}, \widetilde{V}_{f}^{(\ell, \ell+1, t)}\right\rangle \\
& =\left\langle f,\left(-\Delta_{c(\ell)}+m t\left(F^{\prime} \sin F\right) f\right\rangle_{2}=\langle f, R(\ell, t) f\rangle_{2}\right.
\end{aligned}
$$

by Lemma 4.1. If $\mathcal{E}_{0}(R(\ell, t))<0$ for some $\ell \in \mathbb{Z}$ and $t \in\{1,-1\}$, then there exists a unit vector $f \in C_{0}^{\infty}((0, \infty))$ such that $\langle f, R(\ell, t) f\rangle_{2}<0$. The above equality shows that $\left\langle\Psi_{f}^{(\ell, \ell+1, t)}, \widetilde{L} \Psi_{f}^{(\ell, \ell+1, t)}\right\rangle<$ 0 . Since $\sigma_{\text {ess }}(\widetilde{L})=[0, \infty)$, it follows from the min-max principal (see [9, Theorem XIII.2]) that the operator $\widetilde{L}$ has a discrete ground state. Therefore so does $\widetilde{H}^{2}$. It follows the existence of a discrete positive or negative energy ground state of $\widetilde{H}$ (and so is $H$ ).

## 5. Supersymmetry breaking

A quadruple $\left\{\mathcal{H}, Q^{2}, Q, \Gamma\right\}$ is called a supersymmetric quantum mechanics if $\mathcal{H}$ is a Hilbert space, $Q$ is a self-adjoint operator on $\mathcal{H}$ and $\Gamma$ is a unitary self-adjoint operator on $\mathcal{H}$ such that $\{\Gamma, Q\}=0$. In the physical literature, the operators $Q$ and $\Gamma$ are called a supercharge and a grading operator, respectively. Initially, we build a supersymmetric quantum mechanics by the fermionic Dirac operators as follows.

Lemma 5.1. Let $H \equiv H(\boldsymbol{n})$ be the fermionic Dirac operator and $\xi$ a unitary self-adjoint operator on $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right)$. A quadruple $\mathcal{Q}(\boldsymbol{n}, \xi):=\left\{L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right) \otimes \mathbb{C}^{2}, H^{2}, H, \sigma_{3} \otimes \xi\right\}$ consists a supersymmetric quantum mechanics if and only if $\{\xi, \boldsymbol{n} \cdot \boldsymbol{\tau}\}=0$.

Proof. Let us set $\Gamma=\sigma_{3} \otimes \xi$. We can regard $m \sum_{j=1}^{3} \sigma_{3} n_{j} \otimes \tau_{j}$ as the operator $m \sigma_{3} \otimes(\boldsymbol{n} \cdot \boldsymbol{\tau})$. Since $\left\{\sigma_{3}, \sigma_{1}\right\}=\left\{\sigma_{3}, \sigma_{2}\right\}=0$, we get $\left\{\sigma_{3},\left(-i \sigma_{2} D_{1}+i \sigma_{1} D_{2}\right)\right\}=0$, and therefore $\left\{\Gamma, H_{0}\right\}=0$ without a condition of $\xi$. Thus, the desired result holds thanks to the following equality

$$
\left\{\Gamma, \sigma_{3} \otimes(\boldsymbol{n} \cdot \boldsymbol{\tau})\right\}=\left[\sigma_{3}, \sigma_{3}\right] \otimes \xi(\boldsymbol{n} \cdot \boldsymbol{\tau})+\sigma_{3}^{2} \otimes\{\xi, \boldsymbol{n} \cdot \boldsymbol{\tau}\}=1_{2} \otimes\{\xi, \boldsymbol{n} \cdot \boldsymbol{\tau}\} .
$$

By using Lemma 5.1, we present a characterization of unitary self-adjoint operators $\xi$ on $L^{2}\left(\mathbb{R}^{2} ; \mathbb{C}^{2}\right)$ such that $\mathcal{Q}(\boldsymbol{n}, \xi)$ constitutes a supersymmetric quantum mechanics.

Example 5.2. If $\xi=f_{0} \tau_{0}+f_{1} \tau_{1}+f_{2} \tau_{2}+f_{3} \tau_{3}$ for some $f_{j} \in L^{2}\left(\mathbb{R}^{2}\right)(j=0,1,2,3)$ and $\tau_{0}=1_{2}$, then
(i) For any $\boldsymbol{x} \in \mathbb{R}^{2}$, we have $f_{j}(\boldsymbol{x}) \in \mathbb{R}$ for all $j=0,1,2,3$ (since $\xi$ is self-adjoint).
(ii) For any $\boldsymbol{x} \in \mathbb{R}^{2}, \sum_{j=0}^{3}\left|f_{j}(\boldsymbol{x})\right|^{2}=1$ (since $\xi$ is unitary).

Note that $\{\xi, \boldsymbol{n} \cdot \boldsymbol{\tau}\}=2\left(\sum_{j=1}^{3} f_{j} n_{j}\right) \tau_{0}+2 f_{0} \sum_{j=1}^{3} n_{j} \tau_{j}$. If $\{\xi, \boldsymbol{n} \cdot \boldsymbol{\tau}\}=0$, then $\sum_{j=1}^{3} f_{j} n_{j}=0$ and $f_{0} n_{j}=0$ for all $j=1,2,3$ since $\left\{\tau_{j}\right\}_{j=0}^{3}$ is an orthonormal basis in $M_{2}(\mathbb{C})$. Because $\|\boldsymbol{n}(\boldsymbol{x})\|=1$ a.e.
$\boldsymbol{x} \in \mathbb{R}^{2}$, we have $\left(n_{1}, n_{2}, n_{3}\right) \neq(0,0,0)$, and therefore it must be $f_{0}=0$. We particularly consider $n_{3} \neq 0$. Then $f_{3}=-\frac{n_{1}}{n_{3}} f_{1}-\frac{n_{2}}{n_{3}} f_{2}$. Finally, the above condition (ii) implies

$$
1=\left(1+\frac{n_{1}(\boldsymbol{x})^{2}}{n_{3}(\boldsymbol{x})^{2}}\right) f_{1}(\boldsymbol{x})^{2}+\left(1+\frac{n_{2}(\boldsymbol{x})^{2}}{n_{3}(\boldsymbol{x})^{2}}\right) f_{2}(\boldsymbol{x})^{2}-\frac{2 n_{1}(\boldsymbol{x}) n_{2}(\boldsymbol{x})}{n_{3}(\boldsymbol{x})^{2}} f_{1}(\boldsymbol{x}) f_{2}(\boldsymbol{x}),
$$

for $\boldsymbol{x} \in \mathbb{R}^{2}$. For example,

- If $f_{2}=0$, then $f_{1}=\frac{\left|n_{3}\right|}{\sqrt{n_{1}^{2}+n_{3}^{2}}}$ and $f_{3}=\frac{\left|n_{1}\right|}{\sqrt{n_{1}^{2}+n_{3}^{2}}}$. Hence $\xi=\frac{\left|n_{3}\right|}{\sqrt{n_{1}^{2}+n_{3}^{2}}} \tau_{1}+\frac{\left|n_{1}\right|}{\sqrt{n_{1}^{2}+n_{3}^{2}}} \tau_{3}$.
- Similarly, if $f_{1}=0$, then $\xi=\frac{\left|n_{3}\right|}{\sqrt{n_{2}^{2}+n_{3}^{2}}} \tau_{2}+\frac{\left|n_{2}\right|}{\sqrt{n_{2}^{2}+n_{3}^{2}}} \tau_{3}$.

By Lemma 5.1, $\mathcal{Q}(\boldsymbol{n}, \xi)$ consists a supersymmetric quantum mechanics under the above cases for $\xi$.
A supersymmetric quantum mechanics $\left\{\mathcal{H}, Q^{2}, Q, \Gamma\right\}$ is said to have a supersymmetric state if $\operatorname{ker} Q \neq\{0\}$. Furthermore, a supersymmetric quantum mechanics is said to be supersymmetry (SUSY) breaking if it has no supersymmetric states.

Lemma 5.3 ([2]). Let us

$$
V_{0}=\left(\begin{array}{cc}
0 & W_{0}^{*} \\
W_{0} & 0
\end{array}\right),
$$

where $W_{0}$ is a bounded operator on some Hilbert space. Then we have $\sigma\left(V_{0}^{2}\right)=\sigma\left(W_{0} W_{0}^{*}\right)$. In particular, $\left\|V_{0}\right\|=\left\|W_{0}\right\|$.

We recall Lemma 2.2 and Remark 2.3 that for $\boldsymbol{n}=\left(n_{1}, n_{2}, n_{3}\right) \in \mathcal{N}$,

$$
H^{2}=-\Delta+m^{2}+\underbrace{\left(\begin{array}{cc}
0 & W^{*} \\
W & 0
\end{array}\right)}_{=V}
$$

where $W=-m \sum_{j=1}^{3}\left(\left(D_{1} n_{j}\right)+i\left(D_{2} n_{j}\right)\right) \otimes \tau_{j}$. If $\boldsymbol{n}=\boldsymbol{n}(F)$ is the hedgehog-ansatz with $F \in \mathcal{F}$ and $\lim \sup _{r \rightarrow 0^{+}}\left|\frac{\sin F(r)}{r}\right|<\infty$, then

$$
\widetilde{W}:=\left(U \otimes 1_{2}\right) W\left(U \otimes 1_{2}\right)^{-1}=-m\left(\begin{array}{cc}
\widetilde{R}_{1} & \widetilde{R}_{2} \\
\widetilde{R}_{3} & -\widetilde{R}_{1}
\end{array}\right),
$$

where

$$
\begin{aligned}
& \widetilde{R_{1}}=-F^{\prime}(r) \sin F(r) e^{i \varphi}, \\
& \widetilde{R_{2}}=\left(F^{\prime}(r) \cos F(r)+\frac{N}{r} \sin F(r)\right) e^{-i(N-1) \varphi}, \\
& \widetilde{R_{3}}=\left(F^{\prime}(r) \cos F(r)-\frac{N}{r} \sin F(r)\right) e^{i(N+1) \varphi} .
\end{aligned}
$$

One can see that

$$
\begin{equation*}
\|\widetilde{W}\|=m \sup _{r>0} \sqrt{\left|F^{\prime}(r)^{2}-\left(\frac{N}{r} \sin F(r)\right)^{2}\right|} \tag{5.1}
\end{equation*}
$$

Theorem 5.4 (Theorem (1.4). Let us consider $\boldsymbol{n}=\boldsymbol{n}(F) \in \mathcal{N}$ with $\lim _{\sup }^{r \rightarrow 0^{+}}$$\left|\frac{\sin F(r)}{r}\right|<\infty$. If

$$
\begin{equation*}
m>\sup _{r>0} \sqrt{\left|F^{\prime}(r)^{2}-\left(\frac{N}{r} \sin F(r)\right)^{2}\right|}, \tag{5.2}
\end{equation*}
$$

then $\mathcal{Q}(\boldsymbol{n}, \xi)$ is SUSY breaking for any unitary self-adjoint operators $\xi$ with $\{\xi, \boldsymbol{n} \cdot \boldsymbol{\tau}\}=0$.
Proof. Fix an arbitrary unitary self-adjoint operator $\xi$ such that $\{\xi, \boldsymbol{n} \cdot \boldsymbol{\tau}\}=0$. Then

$$
\begin{aligned}
E_{0}\left(H^{2}\right) & =\inf _{\|\Phi\|=1}\left\langle\Phi, H^{2} \Phi\right\rangle \\
& \geq m^{2}+\inf _{\|\Phi\|=1}\langle\Phi, V \Phi\rangle \\
& \geq m^{2}-\|V\| \\
& =m^{2}-\|\widetilde{W}\| \quad \quad \text { (by Lemma } 5.3 \text { and the unitary invariance) } \\
& =m^{2}-m \sup _{r>0} \sqrt{\left.\left|F^{\prime}(r)^{2}-\left(\frac{N}{r} \sin F(r)\right)^{2}\right| \quad \text { (by (5.1) }\right) .}
\end{aligned}
$$

The assumption (5.2) shows that $E_{0}\left(H^{2}\right)>0$, and therefore $\operatorname{Ker} H=\{0\}$ as desired.
To end this section, we provide an example of the supersymmetric quantum mechanics $\mathcal{Q}(\boldsymbol{n}(F), \xi)$ in which $H=H(\boldsymbol{n}(F))$ has a discrete ground state while being the absence of supersymmetry. More precisely, we find $F \in \mathcal{F}$ such that $\lim \sup _{r \rightarrow 0^{+}}\left|\frac{\sin F(r)}{r}\right|<\infty$ and two conditions (4.1) and (5.2) hold true. According to Theorems 1.3 and 1.4, such a vector field $\boldsymbol{n}(F)$ presents the desired supersymmetric quantum mechanics $\mathcal{Q}(\boldsymbol{n}(F), \xi)$. Before giving it, we give the following mollifier:

$$
\begin{equation*}
f_{0}(r):=C r e^{-\frac{1}{1-r^{2}}} \chi_{\{0<r<1\}}(r) \quad \text { and } \quad C:=\left(\int_{0}^{1} r^{3} e^{-\frac{2}{1-r^{2}}} \mathrm{~d} r\right)^{-\frac{1}{2}} \tag{5.3}
\end{equation*}
$$

where $\chi_{A}$ is the indicator function on $A \subset(0, \infty)$. One can see that the function $f_{0}$ is in $C_{0}^{\infty}((0, \infty))$ and $\left\|f_{0}\right\|_{2}=1$.
Example 5.5. If we set $N=1$ and define $F(r)=\frac{\pi}{r+1}, r>0$, then $F \in \mathcal{F}$ and $\lim \sup _{r \rightarrow 0^{+}}\left|\frac{\sin F(r)}{r}\right|<$ $\infty$. Consequently, we obtain

$$
\sup _{r>0} \sqrt{\left|F^{\prime}(r)^{2}-\left(\frac{N}{r} \sin F(r)\right)^{2}\right|} \approx 1.223
$$

To meet the condition (5.2), we choose $m \geq 1.23$.
Next, we choose $m$ such that $\frac{1}{2}<\frac{9 \pi}{200} m-\frac{5}{2}$, which implies $m>\frac{200}{3 \pi} \approx 21.22$. Additionally, we choose $\ell \in \mathbb{Z}$ such that $c(\ell)^{2}<\frac{9 \pi}{200} m-\frac{5}{2}$. The existence of such $\ell$ is guaranteed due to the chosen value of $m$ and the fact that $c(\ell)^{2} \geq \frac{1}{2}$ holds for all $\ell \in \mathbb{Z}$. For the function $f_{0}$ defined in (5.3),

$$
-\Delta_{c(\ell)} f_{0}(r)=\left\{\frac{-4\left(3 r^{2}-2\right)}{\left(1-r^{2}\right)^{4}}+\frac{c(\ell)^{2}-1}{r^{2}}\right\} f_{0}(r)
$$

and therefore $\left\langle f_{0},-\Delta_{c(\ell)} f_{0}\right\rangle_{2} \leq 15+6 c(\ell)^{2}$. Moreover, if we take $t=1$, then

$$
\begin{aligned}
\left\langle f_{0}, m t F^{\prime} \sin F f_{0}\right\rangle_{2} & =\left\langle f_{0},-\frac{m \pi}{(r+1)^{2}} \sin \left(\frac{\pi}{r+1}\right) f_{0}\right\rangle_{2} \\
& =-m \pi \underbrace{\left(\int_{0}^{1} r^{3} e^{-\frac{2}{1-r^{2}}} \mathrm{~d} r\right)^{-1}}_{\approx 270.23} \underbrace{\int_{0}^{1} \frac{r^{3}}{(r+1)^{2}} \sin \left(\frac{\pi}{r+1}\right) e^{-\frac{2}{1-r^{2}}} \mathrm{~d} r}_{\approx 0.00135476} \\
& \leq-\frac{27 \pi}{100} m .
\end{aligned}
$$

With the appropriate choice of values for $m$ and $\ell$, we ultimately attain

$$
\begin{aligned}
\mathcal{E}_{0}\left(-\Delta_{c(\ell)}+m t F^{\prime} \sin F\right) & \leq\left\langle f_{0},\left(-\Delta_{c(\ell)}+m t F^{\prime} \sin F\right) f_{0}\right\rangle_{2} \\
& =15+6 c(\ell)^{2}-\frac{27 \pi}{100} m \\
& <0
\end{aligned}
$$

The conditions (4.1) and (5.2) are satisfied, especially when $m \geq 21.23$.
